



Bursary Application

As part of our founding values, Lake View Credit Union places great importance on the youth in our communities. It is with great pride that we offer our “Face of the Future” Bursary Program to the youth in Dawson Creek, Tumbler Ridge, and Chetwynd. It is our sincere hope that this financial assistance will make a difference and that it will help deserving students reach their potential through post-secondary education.

What Our Program Offers:

Lake View Credit Union will provide financial assistance of one thousand (\$1,000) dollars to five (5) bursary recipients. The five (5) bursaries will be awarded to students enrolled in a secondary school in the South Peace Region.

You will notice that we have preferred to refer to the funding as a Bursary rather than a Scholarship. It is our understanding that “Scholarship” is purely academic, and thus a student’s academic performance is the sole factor in determining his/her success in winning an award (scholarship).

“Bursary” considers not only academic achievement, but also the financial need and character of the individuals who apply. Successful candidates are determined in a more wholistic manner.

Selection Criteria for Lake View Credit Union Bursaries

- Applicants must be a member of Lake View Credit Union (no later than March 1st of the year of application).
- Applicants must achieve secondary school graduation in June of the year of application.
- Applicants must be enrolled in a post-secondary institution the year or following year of graduating high school. (For example – if you graduate in 2025 you have until the end of 2026 to be enrolled in a post-secondary institution).
- Applicants must complete a bursary application and return it with all required supporting documents to the Lake View Credit Union by May 16th, 2025.

Lake View Credit Union Community Social Responsibility Committee will determine the successful candidates, rewarding committed students with the greatest needs.
